Praying for Some Brave Nation to Step into the Breach

Stop the "Consent by Silence Procedure" of a Worldwide Declaration in Support of the WHO's Unprecedented Power Grab at Tomorrow's UN/WHO High Level Meeting

We are in the battle of our lives, and most people don't know it. A trap has been set for us by the World Health Organization (WHO) and the United Nations. Some brave nation has the opportunity to change the course of world history by standing in opposition to a vote at the United Nations tomorrow, September 20, 2023.

On September 20, the UN is hosting one of three high-level [meetings](#) on health with WHO officials attending.

At the "Pandemic Prevention, Preparedness and Response" ("PPPR") meeting on the 20th, the proposed outcome will be a [political declaration](#) that "aims at '[mobilizing political will](#) at the national, regional and international levels for pandemic prevention, preparedness and response.'" This meeting and the document they will pass – unless one country objects -- appear to be designed to provide political momentum to the passage of the problematic Amendments to the International Health Regulations and the new proposed pandemic treaty, both of which would seriously compromise if not destroy our national sovereignty and personal medical freedom.

Taken together, these pandemic instruments would **destroy essential freedoms: freedom of speech, freedom of the press, freedom of assembly. These proposed actions would threaten the sovereignty of nations, as well as personal medical freedom. Indeed, they would destroy Western Civilization.**

These instruments cannot be fixed. At their core is a globalist attempt to seize control of our national sovereignty and personal freedom.

In the proposed Amendments of the International Health Regulations:

- The word “non-binding” has been deleted to make the “recommendations” of the WHO **binding**.
- The WHO will be able to intervene not only when an active public health risk exists, but also when the public health risk is only **potential**.

The Proposed Pandemic Treaty:

- **Establishes Global Surveillance**, no doubt through Vaccine Passports, Smart Health Cards, or other forms of digital IDs, which can give rise to a Chinese-style Social Credit System.
- **Commits governments to Censor Dissenting Views** (Article 17, p. 23). “The Parties commit to ... tackle false, misleading misinformation or disinformation ... each party is encouraged ... **to counteract misinformation, disinformation and false news, thereby strengthening public trust.**”
- **“One Health Approach”** (Article 18, #3, pg. 24). One Health includes not only human health, but also the health of animals, agricultural plants, and the environment. **If passed, the WHO would have control over every aspect of existence on earth.**

The two WHO instruments will come to a vote at the World Health Assembly in May 2024.

The UN, in cooperation with the WHO, proposes to pass this PPPR document through its [“Silence Procedure.”](#) Under this procedure, unless a nation objects to the document, it is deemed to have passed unanimously. If one country objects, it derails this process. “If there are objections, the President of the UN General Assembly will circulate a letter that the silence has been broken.”

A pause is needed. We respectfully pray that some brave nation would stymie this latest UN/WHO power grab by objecting. According to paragraph 5 of the [“Silence Procedure”](#) document:

5. Member States wishing to make an objection may do so via a letter or Note Verbale addressed to the President of the General Assembly. Such correspondence should [be] sent via email to opga@un.org. Please indicate the title of the draft decision/resolution in the subject line of the communication.

All nations ought to object, but it takes just one holdout to force a vote. . Forcing a vote would give time to discuss the dangers posed by the WHO’s proposed pandemic power grab.
