THE “NOT NOW” DECLARATION

To All State GOP Chairs:

I would like to thank Georgia GOP Chair Josh McKoon for helping us get out this important information.

On October 30, 2008, Senator Barack Obama declared, "We are five days away from fundamentally transforming the United States of America." In the intervening years, myriad actions have been taken that have had that effect, possibly permanently.

These changes include: opening our borders; adopting Obamacare; weakening our military; undermining election integrity; underwriting and otherwise empowering and emboldening the Chinese Communist Party (CCP); hollowing out our energy security, ostensibly to prevent “climate change”; devaluing the dollar and endangering its status as the world’s reserve currency; promoting policies like abortion, cultural Marxism and transgenderism that afflict and break apart America’s families and ravage our society; and permitting fentanyl to kill tens of thousands of Americans annually.

The individual principally responsible for promoting the China Model here and elsewhere in the world was the Director-General of the World Health Organization (WHO), Tedros Ghebreyesus. He is not a medical doctor. He is an Ethiopian Maoist selected for the job by the Chinese Communist Party and is dutifully serving as their puppet. He serially lied about the COVID-19’s origins, nature, and the appropriate means of dealing with it. With help from equally dishonest enablers inside the U.S. government, his *recommendations* were implemented in the United States disastrously.

Incredibly, the Biden administration seeks now to reward Dr. Tedros for such malfeasance by stealthily surrendering to him unprecedented power and our national sovereignty. He will hold diplomatic immunity, there will be no court to present challenges to his decisions, and he will have total control of the budget within a system yet to be defined. He will have complete dictatorial powers over all nation-states healthcare systems and will, in essence, become the most powerful man in the world.

In fact, the Chinese Communist Party and other proponents of this unprecedented concentration of power describe it as “global governance”. Once approved it will be the beginning of the World Economic Forum’s “One World Government” and will be a structure clearly at odds with and incompatible with our system of limited, representational, and accountable government under our U.S. Constitution.

No one who claims to support “democracy” – let alone to be committed to *defending* it – can favor this plan to let an unelected, unaccountable foreign bureaucrat dictate U.S. public health, especially without the voters’ knowledge or agreement.

That is especially true given Tedros Ghebreyesus’ record of incompetence and malfeasance, his totalitarian, Marxist background and what he has already expansively described as public health emergencies of international concern (PHEIC). Among those are: “climate change,” reproductive rights, transgender rights, poverty, instability, migration, disruptive social viewpoints (MAGA?) and “gun violence.” The possibilities are endless, as he will not have any constraints. It is predictable that Dr. Tedros’ prescriptions for contending with such emergencies will not be compatible with our constitutional rights, values, or national interests. On the contrary, for the sake of our National Security, we must anticipate he will be a willing participant in China’s ceaseless “Unrestricted Warfare” efforts to destroy the United States and assist China in securing their stated objective to achieve worldwide hegemony by 2049.

For all these reasons, this is clearly not the time for the United States to fall prey to the Biden administration’s and the World Health Assembly’s attempt to jam through World Health Organization treaties. The push for a vote is about to become a Nancy Pelosi moment: “*You’ll have to pass the (amendments) to find out what’s in (them!)*” – but this time it will be at the cost of our state’s and national sovereignty.

When President Trump was in office, he was right to announce the United States’ withdrawal from the World Health Organization. He was also correct in announcing that, following President Biden’s termination of that action, he will take us out of the WHO when he returns to office. In the meantime, these grievously defective treaties must not be approved and allowed to become binding on the United States and other freedom-loving nations.

We believe that every political leader who has taken an oath of office to “support and defend” the U.S. Constitution – and everyone who aspires to do so – must join us in saying “**Not Now**” to the consideration and approval of the two WHO treaties.

Therefore, as the Chair for your state’s GOP, please join this fight and use your position to inform and move your citizens, elected and appointed officials to action. Our objective is to make this an election issue by shedding sunlight on what is the most consequential threat to our country today. By doing so we will force the Democrats to defend their indefensible position of knowingly giving away our State’s sovereign rights to manage their own healthcare systems to unelected, unaccountable foreign bureaucrats. We do not have a lot of time, as the treaty proponents are seeking to push it through by May 27, 2024. Your immediate attention is required. The good news is there is a great swell of activity in the making as I write and the momentum about to emerge will be amazing.

**GOP STATE RESOLUTION REGARDING
THE WORLD HEALTH ORGANIZATION**

A Resolution on Combatting Chinese Influence – World Health Organization

**AT THE [CONVENTION] FOR THE STATE OF [STATE], THE MEMBERS
GATHERED HEREBY ADVANCE THE FOLLOWING:**

A RESOLUTION, Urging the United States Government to Oppose Further Enabling the World Health Organization, asserting state sovereignty over health care freedom and choice; and for other purposes.

WHEREAS, the World Health Organization (“WHO”) has proven itself to be a corrupt organization that has hampered worldwide public health efforts; and

WHEREAS, WHO has a history of mismanagement and scandals, including the coverup of severe sexual abuse by its staff in the Democratic Republic of the Congo following an Ebola viral outbreak there; and

WHEREAS, WHO is an opaque organization unaccountable to the United States government despite receiving between \$200 and \$600 million annually in US taxpayer subsidies over the past decade; and

WHEREAS, WHO as an organization has chosen to place in positions of leadership on its Executive Board representatives of such extreme authoritarian regimes as the People’s Republic of China, the Democratic People’s Republic of Korea, the Syrian Arab Republic, and Belarus, in complete disregard of the human rights abuses regularly committed by these regimes; and

WHEREAS, at the beginning of the 2019 Covid (SARS-CoV-2) outbreak and throughout the pandemic, WHO officials were complicit with the government of the People’s Republic of China in preventing international understanding of the virus and its effects and in covering up its origins, thereby increasing the severity of the pandemic and its death toll; and

WHEREAS, WHO is currently in the process of drafting new International Health Regulations and a proposed Pandemic Preparedness Treaty that will further expand the organization’s authority and empower unelected international bureaucrats through a “One Health” mandate to override national sovereignty in areas including energy, agriculture, climate, and public health; and

WHEREAS, granting WHO such authority would empower authoritarian regimes, contribute to the theft of intellectual property, and erode the sovereignty of western democratic nations in favor of an international technocracy that would have the power

to dictate to sovereign and free nations policies ranging from pandemic response to climate control, threatening western liberal democracy; and

WHEREAS, the United States has its own Centers for Disease Control and Prevention to address issues of domestic and international public health and disease preparedness, which organization is accountable to the people of the United States and their elected representatives;

THEREFORE, BE IT RESOLVED by the Republican Party of the State of [STATE] that the members of this body urge the Representatives and Senators elected by the people of [STATE] to take all steps necessary and reasonable to permanently end taxpayer funding of the World Health Organization; and

BE IT FURTHER RESOLVED that the Convention [or other body] encourages the President of the United States and his foreign policy officials to reject the creation of any policy, law, convention, or regulation, whether through amendments to the International Health Regulations (“IHR”) or through the drafting of an international agreement regarding Pandemic Preparedness, that would in any way further empower this ineffective and corrupt World Health Organization; and

BE IT FURTHER RESOLVED that the Delegates [or members, etc] encourage the United States Government and its representatives to take measures ensuring the fundamental freedoms of the American people against the corrupting influence of international organizations such as World Health Organization that, all too often, are under the influence of authoritarian foreign regimes that do not act in the best interest of the United States; and

BE IT FURTHER RESOLVED that the Republican Party [or other appropriate body] thoroughly and fully rejects any claim of authority by the World Health Organization or any other multinational entity to impose mandates, instructions, communications, or guidance applicable to this State or its residents, and any such efforts shall be considered in violation of the Constitution of [STATE] and of the United States and must be opposed by the government of [STATE]; and

BE IT FURTHER RESOLVED, that any mandates, recommendations, instructions, or guidance issued by the World Health Organization must not be used in this State to direct, order or otherwise impose, contrary to the constitution and laws of the state of [STATE] any requirements whatsoever, including those for masks, vaccines or medical testing, or gather any public or private information about the State’s citizens or residents and shall have no force or effect in [STATE]; and

BE IT FURTHER RESOLVED, to ensure that the State of [STATE], and all states within our Union, maintain full sovereignty over the management of our healthcare systems, that the Republican Party of [STATE] requests the United States Congress to withdraw the United States from membership in the World Health Organization prior to the next meeting convened to vote on the Pandemic Treaty and the International Health

Regulation's related instruments, which meeting is currently scheduled for May, 2024;
and

BE IT FURTHER RESOLVED, that neither the World Health Organization nor any related entity shall have any jurisdiction in [STATE]; and

BE IT FURTHER RESOLVED, that this body, acknowledging Article Ten of the Bill of Rights of the United States Constitution, hereby reasserts its claim to state sovereignty over its rights and responsibilities to ensure the health and safety of its residents, and that the Federal Government, whether acting on its own behalf or at the behest of the World Health Organization or related international bodies, does not have the right to deprive [STATE] of such authority; and

BE IT FURTHER RESOLVED that the [Appropriate Party Official] is hereby authorized and directed to make appropriate copies of this resolution available to the public and the press and to send appropriate copies of this Resolution to the US House of Representatives, Senate, and Executive Branch.
