Dear President Trump:

We write to express our sense of elation that you have withdrawn the United States from the corrupt and incompetent World Health Organization – an issue we have been urgently addressing for years. Thank you for coming through on your campaign promise on your first day in office. As you know, withdrawing from the WHO is the first step towards protecting our national sovereignty and personal medical freedom from the depredations of that malignant globalist entity.

We write also to offer several suggestions regarding next steps to furthering the implementation of these goals.

- 1. Refrain from redirecting the funds to another health-related organization but rather deposit them in a “Health Reserve.”** We suggest that the funds that would have gone to the WHO not be redirected to Gavi, the Bill and Melinda Gates Foundation, or any other organization that is a current or past donor to the WHO. These organizations would likely transfer the funds to the WHO, in which case we would still be funding the WHO indirectly.

In addition, we think it best not to give the funds to any other organization that would propose to replace the WHO. Any global health organization will function as a magnet for globalists to infiltrate and eventually, to take over. Rather, we believe that the funds

should be held in a “Health Reserve,” to be used by the United States in collaboration with other sovereign, like-minded nations, to address global health issues on a voluntary, ad hoc basis.

- 2. Expunge “One Health” initiatives on the national, state and local level, as well as in academia.** The “One Health” [framework](#) promulgated by the WHO – and recently [launched by the CDC](#) -- sounds benign but in fact is pernicious. Using as a pretext the interface between human, animal, plant health and the environment, the “One Health” approach is a means of “balancing” the needs of humans with those of animals, plants and climate change. An article appeared in the Lancet medical journal entitled, [“One Health: A call for ecological equity.”](#) It stated: “All life is equal, and of equal concern” – meaning that a human life is equal to that of a mosquito or a blade of grass. The “One Health” approach may be used to justify the surveillance and control of every aspect of life on earth. It may also be used to restrict people from living in rural areas or visiting wilderness areas, for fear that a pathogen may be spread from a wild animal, such as a bat, to humans.
- 3. Remove all “National Focal Points” and “IHR Authorities.”** The International Health Regulations amended in June, 2024 requires all participating nations to create one or two entities, the “National IHR Authority” and “National IHR Focal Point.” The new National IHR Authority “shall coordinate the **implementation** of these Regulations within the jurisdiction of the State Party.” This implementation shall include State Parties’ “adjusting their domestic legislative and/or administrative arrangements.” Requiring the appointment of a national “IHR Czar,” and requiring nations to “adjust” their domestic laws to implement the IHRs, constitute a violation of the sovereignty of any nation. The U.S. does not need an IHR Czar answerable to the WHO and not to the American people.

Further, requiring the U.S. to enact legislation consistent with the implementation of WHO directives violates the [1948 Joint Resolution](#) by which the United States joined the WHO. Section 5 states: **“In adopting this joint resolution, the Congress does so with the understanding that nothing in the Constitution of the World Health Organization in any manner commits the United States to enact any specific legislative program regarding any matters referred to in said Constitution.”** Arguably, the IHRs have been promulgated under the authority of the WHO Constitution.

- 4. Encourage Congress to enact legislation permanently withdrawing us from the WHO.** Rep. Andy Biggs has introduced H.R. 54, the “WHO Withdrawal Act” which would require the President to withdraw the United States from the Constitution of the World Health Organization (WHO) and prohibit funding for the WHO. This legislation would also repeal the Act of June 14, 1948, providing for U.S. membership in the World Health Organization. Enactment of such legislation would prevent a future president from putting the U.S. back into the WHO by Executive Order.

5. **Withdraw the US from the United Nations’ “Pact for the Future.”** On a related note, in September of 2024, the Biden Administration has agreed to the United Nations’ “Pact for the Future,” a treaty (we would argue) that gives the United Nations the same kind of tyrannical power as the WHO has sought. Specifically, the “Pact for the Future” provides that, in the case of a “complex global shock” (such as a “major climatic event,” supply chain or global connectivity disruption) the United Nations would be in a position of directing the global response via an emergency platform that would operationalize automatically. This dangerous “Pact” may be the subject of a future letter to you.

We are concerned about your recent statement that you might [consider rejoining](#) the WHO if they would “clean it up.” We believe that the WHO cannot be cleaned up, but was corrupt from its inception. Consider, for example, the following quote from the first Director General of the WHO, Brock Chisholm:

*“To achieve world government, it is necessary to remove from the minds of men their individualism, loyalty to family traditions, national patriotism, and religious dogmas.”*

An organization founded upon such principals cannot be reformed. We urge you to remain steadfast to your [campaign promise](#) to withdraw the U.S. from the WHO, “which deserves to be completely abolished.”

Again, we want to express our deep gratitude to you for the Executive Order withdrawing the U.S. from the WHO. As you know, there is already pushback from the WHO and its globalist allies. We stand willing to work with you fully to implement your decision and are eager to help in any way you deem appropriate.
